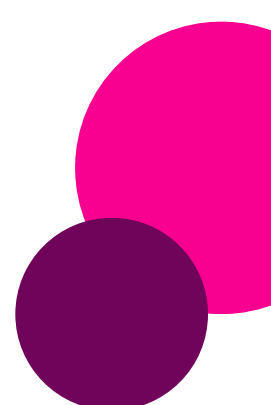
Inspire Allied Health and Education Group offers music tuition to clients with an experienced Music Educator.

# What is a Music Educator?

A Music Educator is a professional who specialises in teaching music to participants of various ages and skill levels. Their primary responsibilities include instructing students in music theory, history, performance techniques, and instrument proficiency.





# Is there a difference between Music Therapists and Music Educators?

Yes. While both Music Therapists and Music Educators work with music, their roles and approaches are quite different. A

Music Therapist is trained to use music as a therapeutic tool to address physical, emotional, cognitive, communicative, and social needs of participants. Music Educators focus on music education, imparting knowledge and skills related to music theory, performance, and technique.



# What qualifications do Music Educators have?

---

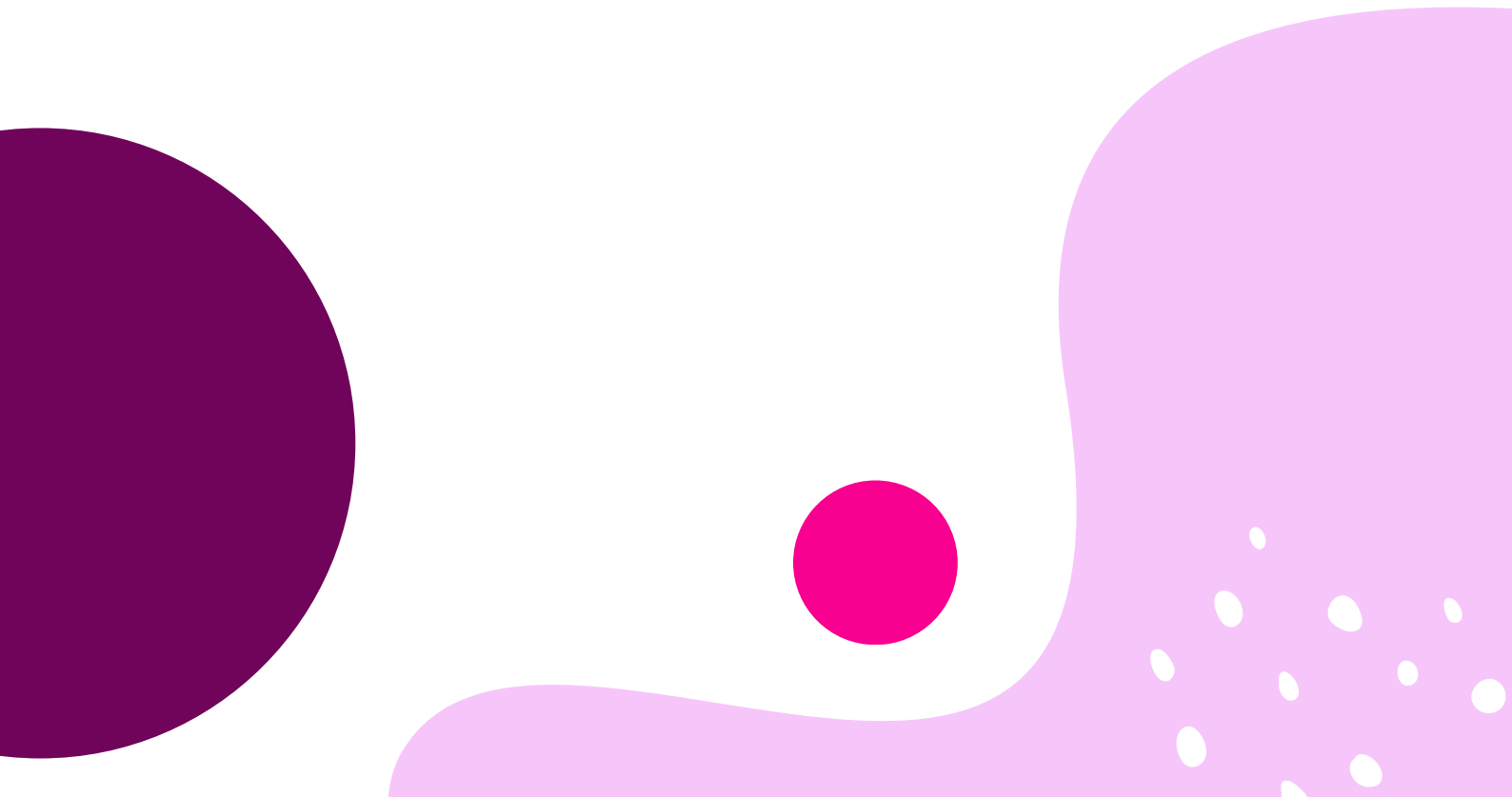
At Inspire Allied Health and Education Group, all Music Educators have a bachelor or master degree in music.

All Music Educators have a current working with children check, national police clearance, first aid certificate as well as training in asthma and anaphylaxis management and child protection. In addition, all Music Educators have completed the NDIS training that supports professionals working with children with complex needs.



# What is the role of a Music Educator?

Music Educators design lesson plans, assess participant progress, provide constructive feedback, and organise performances or recitals to showcase achievements. In addition, Music Educators complete administration tasks including writing file notes and contributing to progress reports as well as design and provide resources and materials for sessions and home practice.





# Supervision and mentoring of Music Educators

All our Music Educators are supported by the Head of Music Therapy and Creative Arts Department. Music Educators engage in weekly supervision, department meetings and team meetings as well as take part in professional development and educational workshops.





# Fees and charges

Our fees are in line with our private paying and NDIS price guides

**70-minute sessions \$101.25**

**40-minute sessions \$57.87**

70-minute sessions are billed at 1 hour therapy assistant rate plus 10 minutes of non-direct clinician time which includes writing and reviewing file notes, planning, and preparing for a session, collaboration with parents, phone calls, emails, writing of goal plans, collaboration between supervising clinician and Music Educator and in clinic multidisciplinary collaboration.

40-minute sessions are billed at 30 minutes therapy assistant rate plus 10 minutes of non-direct clinician time which includes writing and reviewing file notes, planning, and preparing for a session, collaboration with parents, phone calls, emails, writing of goal plans, collaboration between supervising clinician and Music Educator and in clinic multidisciplinary collaboration.



# Attendance and Cancellation Policy

---

Under the Music Educator program, participants are expected to attend all scheduled sessions with the exception of our clinic closure at the end of the year.
